## RESOLUTION 62-15

### AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID OTE: 2015-2 BUTTERWORTH SEWAGE TREATMENT PLANT SAND FILTERS UPGRADE – IN AN AMOUNT NOT TO EXCEED \$531,000.00
