NOTICE TO BIDDERS**

NOTICE IS HEREBY GIVEN that sealed bids will be received by the Bid Committee of the Township of Morris, County of Morris, State of New Jersey on **Wednesday, March 15, 2017** at **11:00 AM** prevailing time at the Municipal Building, Public Meeting Room/Courtroom, 50 Woodland Avenue, Convent Station, New Jersey, at which time and place bids will be opened and read in public for:

DRAINAGE, CURB, & SIDEWALK IMPROVEMENTS AT VARIOUS LOCATIONS  
2017 GENERAL SERVICES PROGRAM**

Specifications and other bid information may be inspected at the Administrator's Office/Purchasing Department, Municipal Building, 50 Woodland Avenue, Convent Station, New Jersey, during regular business hours, Monday through Friday, from 8:30 AM to 4:30 PM.

The major construction items are estimated as follows: 444 L.F. storm drainage pipe, various sizes; 33 Inlets, Type "A", "B" and "E", including reconstruction of various inlets, 44 units of resetting manhole castings; 1,712 L.F. Belgian Block Curb; 3,130 SY of Milling, variable thickness, 301 S.Y. of concrete sidewalk, 416 tons of surface and full depth roadway paving, Right-of-Way restoration and other items typically required of a roadway restoration/ construction project.

Bids for the contract must be submitted on standard proposal forms furnished by the Township of Morris in the manner designated therein and required by the Specifications. Bids must be enclosed in a sealed envelope bearing the name and address of the bidder and must be delivered to the Purchasing Department, Township of Morris, 50 Woodland Ave., PO Box 7603, Convent Station, NJ 07961-7603, and clearly marked on the envelope **OTE: 2017-1 DRAINAGE, CURB, & SIDEWALK IMPROVEMENTS AT VARIOUS LOCATIONS 2017 GENERAL SERVICES PROGRAM** and shall be delivered on or before **WEDNESDAY, MARCH 15, 2017 at 11:00 AM**. NO BIDS WILL BE ACCEPTED AFTER THE BID OPENING HAS COMMENCED. Bids may be hand delivered, mailed, or submitted by courier, and must be received by the time, date, and place specified above. The Township of Morris will not assume responsibility for bids forwarded by mail or delivery service.

The guaranty accompanying the bid proposal shall be given in the amount of ten percent (10%) of the base bid, minimum of \$500.00 and not to exceed twenty thousand dollars (\$20,000.00), and may be given at the option of the bidder by a Certified Check, Cashier's Check, or a Bid Bond from a reputable insurance company licensed in the State of New Jersey.

Pursuant to P.L. 2004, c.57 (N.S.A. 52:32-44) effective September 1, 2004, all business organizations that conduct business with a New Jersey government agency are required to be registered with the State of New Jersey. Bidders and their subcontractors must submit proof that they are registered with the New Jersey Department of Treasury, Division of Revenue by submitting a copy of their Business Registration Certificate. Failure to provide the Business Registration Certificate prior to award of the contract will be cause for rejection of the bid as being nonresponsive.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17-27. Bids may be held by the Township of Morris for a period not to exceed sixty (60) days from the date of opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the contract. Pursuant to P.L. 2010, c. 108, N.J.S.A. 40A:11-23.3 authorizes a bidder to request withdrawal of a public works bid due to a mistake on the part of the bidder within five days after the opening of the bids.

This proposal is being solicited through a fair and open process in accordance with N.J.S.A. 19:44A-20.5 et. seq.

The Township reserves the right to reject any or all bids, if in its judgment the public interest will be best served by so doing.
